

GENERAL ORDINANCE NO. 2012- 2

**AN ORDINANCE OF THE TOWN OF SWEETER, INDIANA,
CREATING A NEW DEPARTMENT TO BE KNOWN AND DESIGNATED AS
SWEETSER REDEVELOPMENT COMMISSION PURSUANT TO I.C. 36-7-14**

WHEREAS, the Legislature of the State of Indiana has authorized cities and towns in Indiana to create new departments to be known and designated as Redevelopment Commissions to serve in a public and governmental capacity in cooperation with private enterprise for the purpose of clearing, replanning and redevelopment of areas needing redevelopment within the Corporate Boundaries of the Town of Sweetser, for public uses and redevelopment by private enterprise existing within the Corporate Boundaries of the Town of Sweetser; and

WHEREAS, the clearance, replanning and redevelopment of such areas in the Town of Sweetser, Indiana, is and would be in the best interests of the citizens of the Town of Sweetser, Indiana, so that a Redevelopment Commission designated as the Sweetser Redevelopment Commission should be and ought to be established in support of such program for the benefit of the Town of Sweetser, Indiana.

NOW, THEREFORE BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF SWEETSER, INDIANA, IN REGULAR MEETING ASSEMBLED THAT:

SECTION 1. A new department to be known and designated as the Sweetser Redevelopment Commission be, and the same is hereby created and established with full power and authority to act as provided pursuant to I.C. 37-7-14.

SECTION 2. The President of the Sweetser Town Council, Sweetser, Indiana, and the Sweetser Town Council, are hereby authorized and empowered to create by appointment five (5) Commissioners for the Sweetser Redevelopment Commission as prescribed in I.C. 36-7-14-6.1 for the purpose of such Commissioners being empowered to do and all things necessary for the promotion of the business and activities of said Sweetser Redevelopment Commission.

SECTION 3. This ordinance shall be in full force and effect from and after its passage, by the Sweetser Town Council.
