**RESOLUTION OF THE SWEETSER TOWN COUNCIL FOR
CONSIDERATION OF PURCHASE OF CERTAIN REAL ESTATE
FOR DEVELOPMENT OF RECREATIONAL FACILITIES**

WHEREAS, the Sweetser Town Council desires to consider the purchase of real estate within the Town of Sweetser or within four (4) miles of the Corporate Boundaries of the Town of Sweetser, Indiana, for the purpose of for development of recreational facilities; and

WHEREAS, the Sweetser Town Council desires for CHARLES V. BRIEDE and STEPHEN L. KELLEY, members of the Sweetser Town Council to act as Purchasing Agents for and on behalf of the Town of Sweetser pursuant to I.C. 36-1-10.5

NOW, THEREFORE, BE IT RESOLVED, the Town Council of the Town of Sweetser, Indiana, now authorizes the following actions pursuant to I.C. 36-1-10.5-1:

1. The Sweetser Town Council as the fiscal body of the Town of Sweetser, Indiana, now finds that it is interested in acquiring appropriate real estate located within the Town of Sweetser, Indiana or within four (4) miles of the Corporate Boundaries of the Town of Sweetser, Indiana, for the purpose of expansion to the West of the Sweetser Switch Walkway, acquisition of walkway on the Northside of Highway 18; and for any other recreational areas for purposes utilizing Federal and State Grants.
2. The Town of Sweetser appoints and designates as its Purchasing Agents for the acquisition of such real estate, CHARLES V. BRIEDE and STEPHEN L. KELLEY, members of the Sweetser Town Council.
3. CHARLES V. BRIEDE and STEPHEN L. KELLEY, members of the Sweetser Town Council, as Purchasing Agents, may proceed to purchase such real estate and improvements pursuant to I.C. 36-1-10.5 and Federal Law under such terms and conditions as they, as Purchasing Agents, deem best with the concurrence and approval of the Sweetser Town Council.
