

**RESOLUTION NO. 2014- 11**

**APPROVING A DECLARATORY RESOLUTION NO. 2014-6 AND ECONOMIC DEVELOPMENT PLAN OF THE REDEVELOPMENT COMMISSION OF THE TOWN OF SWEETSER, INDIANA, AS APPROVED BY RESOLUTION NO. 2014-1 OF THE GRANT COUNTY AREA PLAN COMMISSION**

WHEREAS, the Town of Sweetser ("Town") Redevelopment Commission ("Commission"), on May 22, 2014, initially approved an Economic Development Plan ("Plan") for the Sweetser Economic Development Area ("Area") in the Town and adopted a declaratory resolution initially declaring that the Area is an economic development area and subject to economic development activities pursuant to IC 36-7-14 and IC 36-7-25.1 ("Act"); and

WHEREAS, the Grant County Area Plan Commission ("Plan Commission") approved the Plan and Declaratory Resolution for its member, Town of Sweetser on August 4, 2014; and

WHEREAS the Act requires approval of the Declaratory Resolution and the Plan and the action of the Plan Commission by the Town Council of the Town;

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF SWEETSER, INDIANA, AS FOLLOWS:

1. The Plan for the Area is in all respects approved, ratified and confirmed by the Town Council.
2. The action of the Plan Commission approving the Plan and the Declaratory Resolution is in all respects approved, ratified and confirmed by the Town Council.
3. The Clerk-Treasurer is hereby directed to file a copy of the Declaratory Resolution, the Plan and the approving Resolution No. 2014-1 of the Plan Commission with the permanent minutes of this meeting.
4. This resolution shall be effective from and after passage.
